(Delivered at the Makati Business Club and Philippines-France Business Council Special Membership Meeting with French Republic President François Hollande, 26 February 2015, Fairmont Hotel, Makati City)

We have the distinct privilege of welcoming and hosting President Hollande at the [Special Membership Meeting of the Makati Business Club and the Philippines-France Business Council], on the occasion of his state visit to the Philippines—the first by a president of France since 1947. Our deep historic, cultural, and economic ties have brought us to this very day, where all of us present here are given the rare op-

portunity to celebrate the strong partnership between our two countries.

Our business communities take pride in the fact that both the Philippines and France not only share a mutual ideal and love for liberty and democracy, but also enjoy a robust economic partnership, which we trust will only be further strengthened by President Hollande and his delegation's visit to our shores. To date, France has been consistently one of our country's biggest markets for import and export merchandise trade. More notably, France has risen to become the Philippines' second largest trading partner among the European Union member states.

To underscore the deepening bilateral links between our enterprises, I am happy to announce that a total of six business contracts and agreements were formally signed between Philippine and French companies for approved projects and modes of cooperation in a number of sectors. Moreover, a big-ticket project pre-contract will be signed between the Light Rail Manila Consortium and French company Bouygues/ Alstom, for construction of the LRT-1 extension.
